

MC EVENT LOOS - TERMS & CONDITIONS

1. GENERAL

1. All business is undertaken in accordance with these Terms & Conditions unless otherwise agreed in writing by MC Event Loos.
2. Acceptance of the "Unit(s)" on site by the "Hirer" shall in itself constitute full acceptance of these Terms & Conditions.
3. "Company" is MC EVENT LOOS
4. "Hirer" means the person or their representative hiring the unit.
5. "Unit" means the mobile Trailer Toilet unit including all fixtures, fittings and consumables.
6. "Period of Hire" means the period from the date of delivery until date of collection as agreed.
7. Quotes will be provided upon request and remain valid for 30 days only from the date of quotation.

2. COMPANY RESPONSIBILITIES

1. The Company will deliver the Unit(s) on the delivery date ensuring it is clean and in good working order and collect on the agreed collection date at the time arranged.
2. The Company will provide a Quote on the assumption that the site is flat and level, free from trees and overhead obstructions with suitable access for both the Unit and delivery/collection vehicle.
3. The Company will not be responsible for making good or repairing any damage to the site unless caused by the Company's negligence.
4. The Company will not be liable for any third party claims or for loss or damage of any kind. MC Event Loos will not be held responsible if a Fridge Trailer breaks down due to loss of power. The client will be liable for any loss if this results in food or contents being wasted.

3. HIRERS RESPONSIBILITIES

1. The Hirer agrees to pay the Deposit on confirmation of booking and balance as agreed with the Company. The Company reserves the right to charge interest on late payments.
2. The Hirer will ensure that the site will have suitable access and be free from overhead obstructions or underground services which may suffer damage as a result of the delivery siting or collection of the Unit.
3. The Hirer will be liable for any damage caused to the Company's vehicles or unit due to unsuitable access or site conditions.
4. The Hirer accepts responsibility for any damage to the Unit/Equipment throughout the Period of Hire and the Hirer MUST ensure that appropriate insurance has been arranged for the Unit/Equipment.
5. The Hirer agrees not to install or affix any additional fixtures, fittings or decorative ornamentation to the Unit whatsoever.
6. The Hirer will be responsible for providing appropriate electricity supply (240 Volt) for the Unit or advising the Company who will be able to provide a Generator if required, at an additional cost.
7. The Hirer will NOT move the Unit from where it is sited by the Company.
8. The Unit remains the property of the Company at all times.
9. The Hirer agrees that the Period of Hire and numbers utilizing the equipment will not exceed the information provided to the Company. The Hirer will be liable if any malfunction of the Unit occurs as a result of misrepresentation.
10. The Hirer will ensure that the Unit is ready for collection on the agreed date and time in an acceptable condition. If the Unit is not in an acceptable condition, the Hirer will be liable for additional cleaning charges.

4. PAYMENT DETAILS

1. A Deposit of £100 plus VAT (£120) per Unit will be required to secure your booking and is NOT refundable if cancelled.
2. Final payment will be due 14 days before hire date. If cancelled within 14 days of event, full payment will NOT be refunded.

5. SITING OF EQUIPMENT

1. MC Event Loos will site the Toilet Unit(s)/Equipment to the Hirer's instructions, clear access will be required before delivery takes place. Hedges will be required to be cut back if overgrown and level ground will be required to site the Unit(s)
2. MC Event Loos take no responsibility for any damage caused to gardens, hedges, pipes, cables etc.
3. Our 3+1 Luxury Units are 5.5m long + drawbar = 7m, 2.3m wide + steps and approx. 3m high.
Our 2+1 Luxury Units are 3.6m long + drawbar = 4.6m, 1.8m wide + steps.
Our 1+1 Luxury Units are 3m long + drawbar = 7m, 2.3m wide + steps and approx. 2.9m high.
Our 3+1 Economy Units are 5.5m long + drawbar = 7m, 2.3m wide + steps and approx. 3m high.
Our 2+1 Economy Units are 3.6m long + drawbar = 4.6m, 1.8 wide + steps
Our 1+1 Economy Units are 3m long + drawbar = 7m, 2.3m wide + steps and approx. 2.9m high.

6. EXTRA CHARGES

1. Any damage to the Unit(s)/Equipment will be subject to charge. No stickers, tape, drawings, pins etc. to be used on or in the Trailers.
2. Any items removed or stolen such as pictures, bins, towels, cables etc. will be charged for at cost price.
3. Extra charges will apply if a Tanker is required for emptying the Toilet(s) on site, please call for quotation.
